Peanut Island - A Tropical Paradise with Historic Significance

Palm Beach County's Parks & Recreation Department has received national awards and recognition for a reason: we provide diverse, safe and affordable recreation service, welcoming parks, and enriching social and cultural experiences. Our sights are set on promoting wellness, practicing environmental stewardship, contributing economic value, and improving this community into the future.

This also includes a commitment to preserving historical sites, like those found on Peanut Island. Excavation performed in 1918 to create the Lake Worth Inlet resulted in the formation of the island, which grew over time as a spoil site. The dredging, which was vital to plans to support the trade of peanut oil out of the Port, led to its name. Now an 80-acre tropical park, Peanut Island is home to a former U.S. Coast Guard Station and boathouse, and the John F. Kennedy Bunker, a Cold-War era nuclear bomb shelter built in 1961.

At the December 13 Upper Level Breakfast of the Business Development Board of Palm Beach County (BDB), attendees received an update from keynote speaker J. Michael Prince, President and CEO of USPA Global Licensing, Inc.

Mr. Prince, who also serves as the District 1 appointee to the BDB, heads the licensing division of the U.S. Polo Association (USPA). With its headquarters now located near Wellington, FL, the USPA has worked for over 130 years to standardize rules and equipment, establish handicaps to more evenly match teams in tournaments held throughout the country, and has instituted many prestigious tournaments.

The BDB estimates that the equestrian industry in Palm Beach County has a direct and indirect economic impact of \$600M, which includes 260 polo games in a four-month season.

Clerk's "Money Drop" Helps Local Foster Children

The Clerk and Comptroller's Circuit Sound held its 25th annual holiday "money-drop" performance on Dec. 14 in the lobby of the Robert Weisman Palm Beach County Governmental Center. This year's concert set a record by raising \$3,600 that was donated to the Selfless Love Foundation, a Jupiter nonprofit organization that works to connect foster children with families and focuses on three key areas: adoption, independent living, and advocacy.

From the floors above the main lobby, employees from different departments and offices showered the carolers with cash or lowered down festive creations adorned with bills.







BCC Briefs for November 15 - December 6, 2022



At the November 15, 2022 Board of County Commissioners meeting, the board took the following action:

Airports – approved an amendment to the maintenance/service agreement with HUB Parking Technology USA Inc. for the parking and revenue control system (PARCS) at Palm Beach International Airport (PBI), extending the agreement to Dec. 31, 2027, updating the components of the PARCS, and increasing the total not to exceed \$1,604,124.37.

Approved the renewal of a term contract for maintenance of airport facilities and systems with ERMC Aviation LLC at PBI, commencing Dec. 6, 2022, and expiring Dec. 5, 2023, with the option to renew for three additional 12-month periods, not to exceed \$1,225,205.00 for the renewal period.

Community Services – approved the updated <u>Substance Use and Mental Disorders Plan report</u>. The 2017 Opioid Crisis: Palm Beach County's Response Plan recommended a coordinated response be created through the designation of a primary entity responsible for the integration of all efforts relative to the epidemic; the need for leadership and guidance from an experienced veteran accustomed to working on solving substance use disorders and the establishment of an opioid response steering committee to guide the County's work. In 2018, Palm Beach County appointed a County Drug Czar and designated the Community Services Department as the entity that would support the work of that position.

Engineering & Public Works – approved a preliminary reading and permission to advertise for a public hearing on Tuesday, Dec. 20, 2022, at 9:30 a.m., regarding an ordinance amending the Palm Beach County Five-Year Road Program.

Facilities Development & Operations – approved a \$2.1 million budget increase of Infrastructure Sales Tax funding under the housing units for homeless, extremely low and low income unit towards the implementation of the Prosperity Village Cottage Homes Project (project); approved an amendment to the developer and operator agreement with the West Palm Beach Housing Authority (WPBHA) to increase the budgeted amount and cap the amount of construction savings transferred at project completion to the Initial Renewal/Replacement (R/R) Project Reserve; authorized the conveyance to the WPBHA of the county's interest in two parcels, at no charge, restricting its use to government use, operation and maintenance for housing of low, very low and extremely low income residents; approved a county deed in favor of the WPBHA.

Approved a preliminary reading and advertisement for a public hearing on Dec. 20, 2022, at 9:30 a.m., in regards to an ordinance amending the county Code; and providing for a repeal of laws in conflict, severability, a savings clause, inclusion in the Code of Laws and Ordinances and an effective date.

Approved the purchase and sale of a parcel of vacant land from Glenn S. Harris and Barbara Valentine-Harris for \$32,550; approved the purchase and sale of vacant land from Jane Couch for \$17,050; approved the purchase and sale of vacant land from Pedro and Ciana Cantillo, trustees of the Pedro Cantillo Living Trust for \$20,150. These purchases add to the county owned parcels for the preservation of these unbuildable lands.

Fire Rescue – approved a letter of understanding with Treasure Coast Health Council Inc., dba Health Council of Southeast Florida, to provide Mobile Integrated Health services for opioid-related prevention components of the Center for Disease Control Overdose Data to Action cooperative agreement, awarded to the Florida Department of Health Palm Beach County, for the period of Oct. 1, 2022, through Aug. 31, 2023, with a cost reimbursement not-to-exceed \$400,000; and approved a budget amendment of \$400,000 within the Fire/Rescue MSTU Fund to recognize the award and establish the program budget.

Housing & Economic Development – approved the issuance of the Palm Beach County Housing Finance Authority Multifamily Housing Revenue Bonds for Lakeside Commons for \$21 million. The bonds are being issued by the Authority to finance the costs of acquiring, rehabilitating and equipping a multifamily rental housing facility containing approximately 99 units known as Lakeside Commons.

Resilience –adopted an ordinance amending the Palm Beach County Code, regarding the Property Assessed Clean Energy (PACE) program; and adopted a resolution establishing the official administrative fee schedule to be charged for reviewing and processing PACE Interlocal Agreements, PACE Indemnification Agreements and residential and nonresidential PACE projects and providing for an effective date.

At the November 22, 2022 Board of County Commissioners meeting, the board took the following action:

Office of Financial Management and Budget – Approved a Resolution of the Board of County Commissioners of Palm Beach County authorizing the issuance of general obligation bonds for workforce and affordable housing units) in the aggregate principal amount not to exceed two hundred million dollars (\$200,000,000) for the purpose of financing all or a portion of increasing workforce and affordable housing in Palm Beach County. Workforce and affordable housing units will consist of the acquisition, construction, and equipping of condominiums, multi-family rental units, single-family homes, and townhomes. Projects can be mixed-income and mixed-use; however, bond financing will only be available for the eligible housing units that meet the County requirements. Projects may be financed by combining other funding to create rental and homeownership opportunities for households earning up to 140% area median income.

Strategic Planning & Performance Management Division's Cross Departmental Teams gave presentations to the board on the different strategic priorities of the county.

The Budget Division presented projections for the Fiscal Year 2024 budget.

BCC- The current board finished old business and said farewell to Mayor Robert Weinroth and Commissioner Melissa McKinlay. A board room at the new Palm Tran headquarters was named for Mayor Weinroth because of his dedication to transportation issues in the county. A facility for transitional housing, Lake Village at the Glades, was named Melissa's Place in honor of Commissioner McKinlay's work on housing in The Glades.

Clerk of the Circuit Court & Comptroller Joseph Abruzzo swore in two new commissioners and one re-elected commissioner to the board. Commissioner Marci Woodward, District 4 and Sara Baxter, District 6 joined Commissioner Gregg Weiss on the board.

Commissioner Gregg Weiss was elected Mayor for a one-year term and Commissioner Maria Sachs was elected as Vice Mayor.

At the December 6, 2022 Board of County Commissioners meeting, the board took the following action:

Administration – concurred with the appointment by the State Surgeon General of Jyothi Gunta, MD, MPS, as the Director of the Palm Beach County Health Department.

Received and filed the updated Board Directive Reports, including in process and completed board directive items.

Airports – approved the Corrective Action Plan required by Federal Aviation Administration (FAA), Final Agency Decision in Forman v. Palm Beach County, FAA Docket No. 16-17-13 for submission to the FAA for approval, providing for a commitment to the repeal of Section 12-6(a) of airport regulations, which prohibits pure turbo-jet aircraft and aircraft over 12,500 pounds, engaging in air cargo operations, from operating at the Palm Beach County Lantana Park Airport.

Community Revitalization – approved the FY 2023 Neighborhood Engagement and Transformation (NEAT) Grant Agreements to implement various community improvement projects and initiatives through the NEAT Grants Program for a total of \$98,000.

Engineering & Public Works – approved a budget transfer of \$1,580,000 in the General Fund from Contingency Reserves to the County Transportation Trust Fund; and approved a budget amendment of \$1,580,000 in the County Transportation Trust Fund to recognize the transfer and appropriate it to Streetscape Section Contractual Services.

Facilities Development & Operations – provided direction to staff to hold a workshop related to the history of the Agricultural Reserve and the potential text amendment to the county's Comprehensive Plan to allow for the development of the Brookside property in light of the restrictions that currently encumber the same.

Financial Management & Budget – provided direction to staff to continue moving forward with the county's current six strategic priorities. The priorities include housing/homelessness, economic development, public safety, substance use and behavior disorders, environmental protection and infrastructure.

Resilience – adopted the Southeast Florida Regional Climate Change Compact Regional Climate Action Plan (RCAP) 3.0; and authorized the signing of a pledge to signify BCC support for regional collaboration, action on climate change, and RCAP 3.0 at the upcoming 14th Annual Southeast Florida Regional Climate Leadership Summit.

Service Awards – presented annual Service Awards to 275 county employees with 20, 25, 30, 35, 40 and 45 years of service.

At the Board of County Commissioners meeting on Nov. 22, 2022, the two outgoing commissioners were honored for their dedicated service.

The Palm Tran South Board Room has been renamed the Robert S. Weinroth Board Room in his honor. Former Mayor Robert Weinroth was a county commissioner from 2018 to 2022 and served as chairman of the Palm Beach County Transportation Planning Agency and the Palm Tran Board, His commitment Service to the transportation needs of the residents of Palm Beach County has left a mark on its growing transit network. His time in public office captured the spirit of innovation in travel through his advocacy for alternatives to private passenger vehicle transport.



The Lake Village at the Glades homeless shelter in Pahokee has been named Melissa's Place in honor of Former Commissioner Melissa McKinlay. She served as a county commissioner from 2014 to 2022. Her tireless and enduring advocacy for the residents of the Glades during her tenure on the board resulted in the establishment of this facility that will provide shelter for those in need. County Program Offers up to \$15,000 for Low-Income Residents to Replace Home Air Conditioning Systems

The crisis Heating Ventilation and Air Conditioning (HVAC) Replacement Program, through LIHEAP (Low-Income Home Energy Assistance Program), is available to assist low-income Palm Beach County homeowners in need of replacing their HVAC systems. Residents may receive assistance up to \$15,000 that can be used to replace a home cooling system.

Clients must be income eligible, live in Pam Beach County and able to show that they are in a crisis situation. Completed applications must show one or more of the following:

- The HVAC system no longer cools
- The HVAC unit is 10 years or older
- Proof of high energy bills
- Proof of a life-threatening environment via a doctor's statement

FDOT Palm Beach County Traffic Report - Construction Projects

SR 9/I-95 at SR 786/PGA Boulevard Southbound Entrance Ramps Project

Description: This 0.65-mile project in Palm Beach Gardens began on November 9. Improvements consist of reconfiguring the I-95 southbound entrance ramps at PGA Boulevard. The I-95 southbound entrance ramp from westbound PGA Boulevard to southbound I-95 will be converted from a merge lane to an additional, free-flowing lane. The I-95 southbound entrance ramp from eastbound PGA Boulevard to southbound I-95 will be reconfigured to become a merge lane. In addition, I-95 will be widened between PGA Boulevard and Burns Road, and lighting, drainage, signage and pavement markings will be upgraded.

- Cost/Completion: \$9,977,382/Spring 2024

State Road (SR) A1A Gravity Wall Replacement Project

Description: This 0.171-mile gravity wall replacement project on State Road (SR) A1A adjacent to John D. MacArthur Beach State Park in North Palm Beach began on July 28, 2022. This project includes replacing the existing gravity wall with a sheet pile wall, replacing sidewalk, curb and gutter, and fencing; milling and resurfacing the roadway; upgrading pavement markings, and signing to the latest standards.

- **Cost/Completion:** 2.3 million/Early 2023
- **Traffic Impact:** The northbound lane just north of John D. MacArthur State Park will be closed daily, 7 a.m. to 7 p.m., Monday through Friday, for sheet pile wall work. Two-way traffic will be maintained by a flagging operation as needed. US 1 Bridge Replacement Project

Description: This 4.1-mile project located in the Town of Jupiter from CR A1A to CR 707/Beach Road and surrounding intersections began October 18, 2021. It consists of replacing the existing US 1 Bridge over the Loxahatchee River, including adding bike lanes and sidewalks in each direction. Other improvements include installing Intelligent Transportation System technology to improve traffic flow, adding decorative lighting and drainage, and upgrading signage and pavement markings. Minor improvements will also be made to the Alternate A1A bridge over the Loxahatchee River. In addition, intersection improvements will occur at Alternate A1A and Old Dixie Highway by shifting the intersection to the southwest, adding a traffic signal, and lengthening the left-turn lane from northbound Alternate A1A to northbound Old Dixie Highway.

- Cost/Completion: \$122 million/2026
- Traffic Impact:

- One southbound lane on US 1 between Jupiter Cove Drive and CR A1A/Ocean Boulevard may be closed from 9:30 a.m. to 3:30 p.m. Monday through Friday for concrete pours at the bascule piers.
- One left-turn lane from northbound US 1 to westbound Indiantown Road may be closed from 9:30 a.m. to 3:30 p.m. Saturday, December 17, for work in the median.
- One southbound lane on US 1 between Breakwater Court and South Coastal Way may be closed from 9:30 a.m. to 3:30 p.m. Saturday, December 17, for work in the median.
- The right-turn lane from southbound US 1 to westbound Indiantown Road may be closed from 9:30 a.m. to 3:30 p.m. Saturday, December 17, for work in the median.
- One lane in either direction on US 1 between Indiantown Road and Breakwater Court may be closed from 9:30 a.m. to 3:30 p.m. Saturday, December 17, through Friday, December 23, to install Intelligent Transportation System infrastructure.
- One lane in either direction on Alternate A1A between Center Street and Sawfish Bay Park may be closed from 9:30 a.m. to 3:30 p.m. Saturday, December 17, through Friday, December 23, to install Intelligent Transportation System infrastructure.
- Alternate A1A's northbound inside lane between the Shoppes of Jonathon's Landing and south of Old Jupiter Beach Road will be closed from 9:30 a.m. to 3:30 p.m. on Thursday, December 22, and Friday, December 23, for paving.
- The outside lane on northbound Alternate A1A north of Riverside Drive and the right-turn lane from Alternate A1A to southbound US 1 is closed continuously through December 30 for intersection improvements at Alternate A1A and Old Dixie Highway.
- Lane closures may occur from 9 p.m. to 6 a.m. Sunday through Saturday on US 1, Indiantown Road, Alternate A1A and Old Dixie Highway.


