We're Waiving Collection Agency Fees March 13 - 17



From **March 13 to 17** we will waive the 25 percent collection agency fee on unpaid traffic tickets and overdue court fines for anyone who pays them in full, giving people whose driver licenses have been suspended because of unpaid fines the opportunity to save money and restore their driving privileges.

Operation Green Light puts the brakes on collection agency fees to help drivers get back on the road.
