


# What is the Clerk of the Circuit Court & Comptroller?

# **Clerk's Personal Liability**

#### **Under Florida Statute 129.09:**

"Any clerk of the circuit court, acting as county auditor, who shall sign any warrant for the payment of any claim or bill or indebtedness against any county funds in excess of the expenditure allowed by law, or county ordinance, or to pay any illegal charge against the county, or to pay any claim against the county not authorized by law, or county ordinance, <a href="mailto:shall-be-personally-liable-for-such-amount">shall-be-personally-liable-for-such-amount</a>, and if he or she shall sign such warrant willfully and knowingly he or she <a href="mailto:shall-be-guilty-of-a-misdemeanor-of-the-second-degree">shall-be-guilty-of-a-misdemeanor-of-the-second-degree</a>, punishable as provided in s. 775.082 or s. 775.083."

- Portfolio will earn almost \$84 million in interest off these most recent purchases





\$139 million more in investment income earned from FY22 to FY23










#### **Focus: On Debt**
